## Purpose

This policy is designed to assist the club in promoting safe transport to and from club events. It includes circumstances where alcohol may be consumed, as well as where minors may be transported by a club official.

## Application of this policy

This policy is designed to apply to transport to and from all club activities.

## Club services

1. The club will endeavour to use its platforms to encourage members to plan how they will get home safely before they go out.
2. When requested, club volunteers will endeavour to provide support to telephone someone (free of charge) so that safe transport can be arranged through the person's friend, family, or taxi service.

## Drivers

3. All drivers providing transport are required to hold the appropriate driver's license and be driving within the law.
4. When transporting minors, all drivers must adhere to the club's child safety code of conduct.
